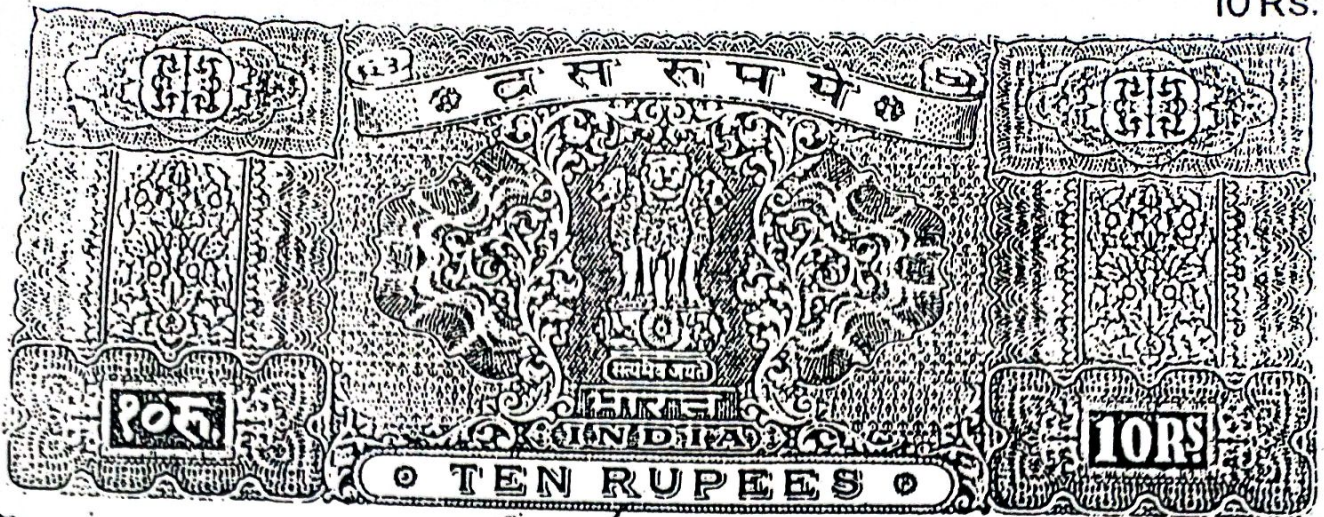

It shall manage schools and hostels and maintain libraries for the promotion of basic and technical education.

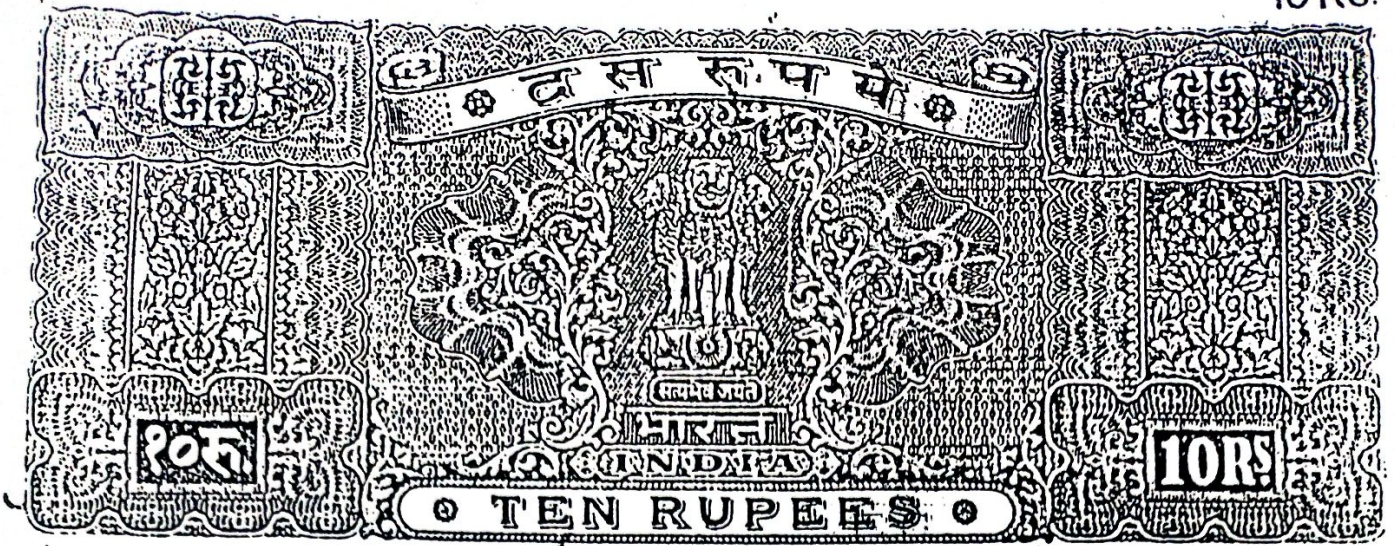

The number of Trustees in the Board of Trustees shall be not less than five. Additional Trustees may be co-opted for specific periods by the Board of Trustees.

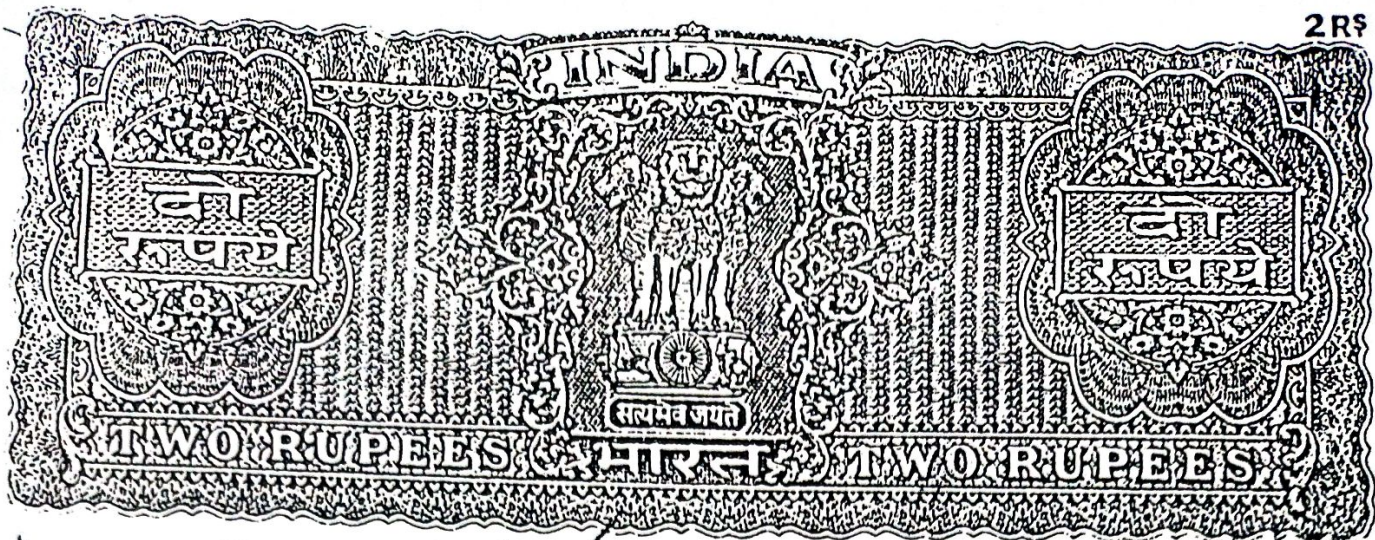

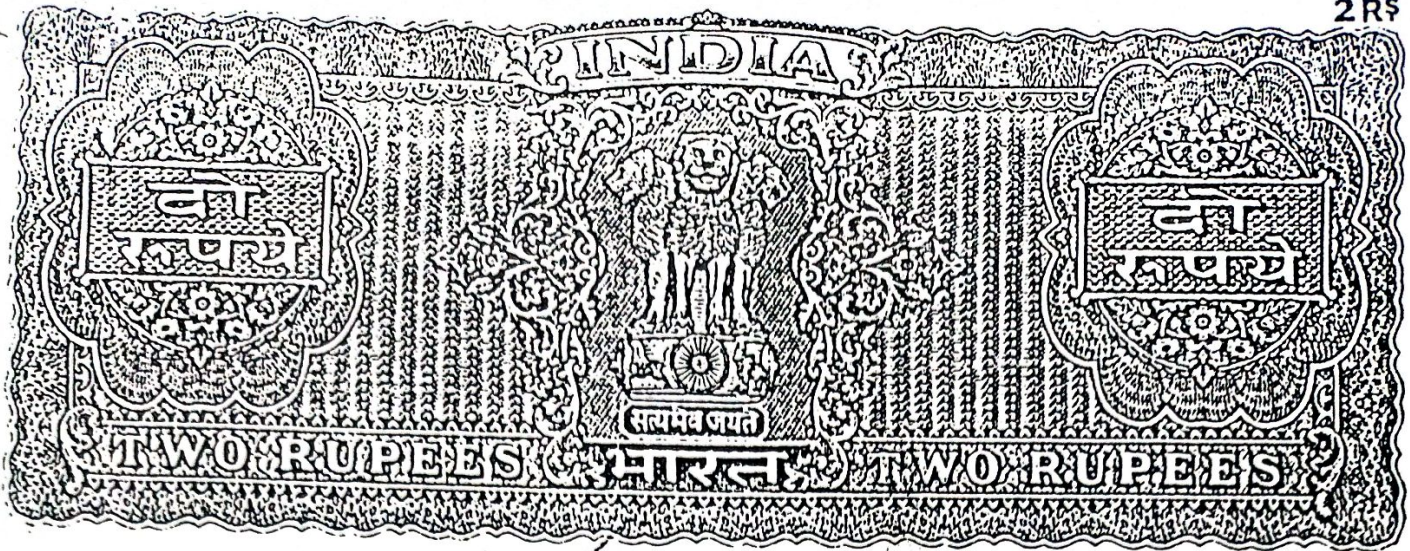

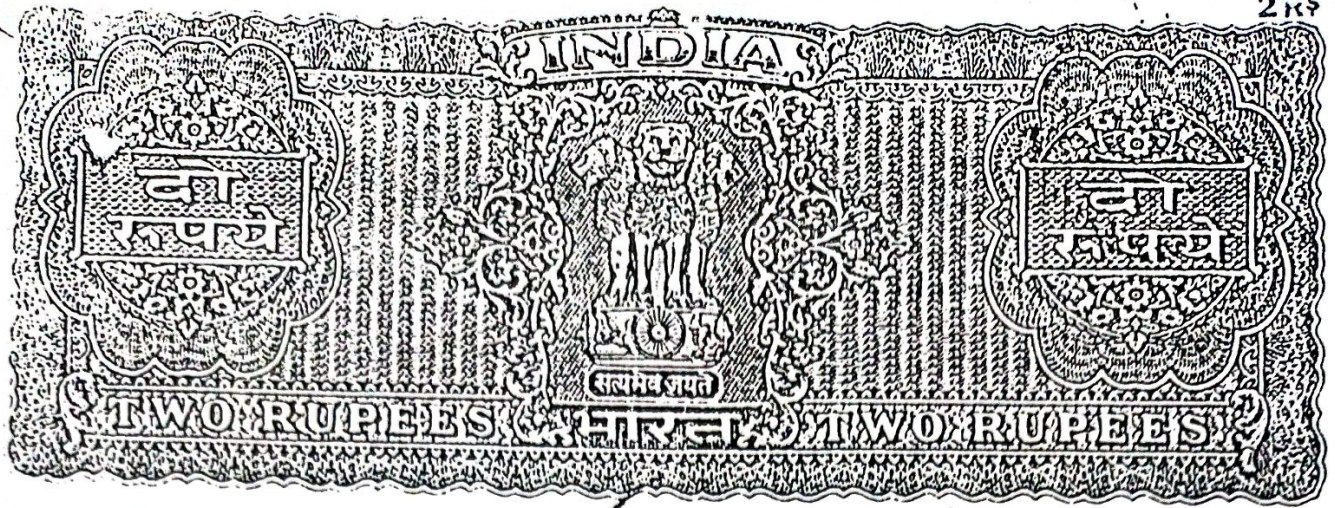
